A.I.G.P. (Crime) Mumbai(missing of minor girl Rukhsar, aged 9 years from Ankleshwar, Gujarat on
30.01.2022)

Respected Sir,

In connection with above subject, it is stated that on the directions of Hon'ble High Court of Gujarat, CBI is investigating the case related to missing of a minor girl Ms. Rukhsar (Aged 9 years, D.O.B. 30.01.2013) who is missing since 30.01.2022 from Ankleshwar, District Bharuch, Gujarat.

It is stated that minor girl Ms. Rukhsar was missing from her home situated at 202/G, Silver City, Miranagar, Sarangpur, Ta. Ankleshwar, Dist. Bharuch after 2 PM and before 5 PM on 30.01.2022, when no other family members were present at the home.

In connection with investigation of the case, it is necessary to verify details of missing girl Ms. Rukhsar with details of (i) girls/child who were/are found involved in cases of Human Trafficking (ii) girls/child resided in all children/women protection homes (iii) unidentified/unclaimed dead bodies found from the period 30.01.2022 till date with descriptions similar to the missing girl Ms. Rukhsar (i.e. female aged 8 to 10 years, height around 4 feet, medium built, matching with photographs of the victim Ms. Rukhsar). It is, therefore, requested

to circulate above details in all Districts of the State and to direct the officers/persons concerned to verify above from all the Districts of the State.

It is further stated that the competent authority of CBI has approved **declaration of cash reward of Rs. 05 Lakh (Rs. Five Lakhs)** to the general public for providing specific/actionable information to trace the missing girl Ms. Rukhsar.

It is, therefore, requested to circulate and make publicity about the details of the missing girl Rukhsar and declaration of cash rewards of Rs. 05 lakh by CBI in the State and also requested to direct concerned officers to verify about missing girl from the record maintained in the state regarding (i) girls/child who were/are found involved in cases of Human Trafficking (ii) girls/child resided in all children/women protection homes (iii) unidentified/unclaimed dead bodies found in the State from the period 30.01.2022, so as to get information which may be helpful in tracing missing girl Rukhsar.

It is stated that the investigation of the case is being monitored by Hon'ble High Court of Gujarat. It is, therefore, requested to do the needful and reply to this office at the earliest.
