

With reference to the subject and reference cited above, the accused Eshappa S/o Erappa @ Veerappa, R/o E.J Hossahalli Camp Tq: Sindhanur Dist: Raichur. was convicted for life imprisonment by the Hon'ble 1st Addl Sessions Court in tumakur Tavarker PS.Cr.No.39/2004 U/s.302,201 IPC and the said Convicted Prisoner No. 9681 Eshappa S/o Erappa @ Veerappa, 32yrs/2004, Kuruba by caste. Occ: Lorry Driver, At: E.J Hossahalli Camp Tq: Sindhanur Dist: Raichur. was in prison for about 08 years and on 17-09-2012, he went on 30 days Parole Leave in connection with his Brother's health issue and for which his friend Yamanappa S/o Duragappa 40 years, harijan E.J hosahalli Camp has given surety for his perole leave. Further, after completion of 30 days perole leave, the said convicted prisoner Eshappa S/o Erappa @ Veerappa, R/o E.J Hossahalli Camp did not return to jail and thereby absconded and in this regard, a case has also been registered in Sindhanur Rural PS vide Cr.No.20/2013 U/s.224, IPC against the convicted prisoner Eshappa S/o Erappa @ Veerappa, R/o E.J Hossahalli Camp
