With due respect, it is hereby stated that Cr. No. 1189003210572/2021 u/s IPC 363, 366 was registered in Morbi City 'A' division Police Station on dated 11/04/2021 at 2030 hrs. The complainant in the above-mentioned case, Srikantsinh Shyamfal Yadav presently residing at Ravapar Road, Teh. Dist. - Morbi, permanent resident of Shahkundanpur, Teh. Tamoli Dist. - Azamgarh (U.P.), has complained that his minor daughter has been kidnapped by Accused Nikunj Bhagwanjibhai Sorathiya/Patel permanent resident of Lothiya, Teh. Dist. - Jamnagar. The case is being investigated by PI M.R.Ghodaniya, Anti-Human Trafficking Unit. The investigation is ongoing and the accused is still absconding.

The complainant has approached the Hon'ble High Court for relief and filed Habeas Corpus petition vide special criminal misc. application no. 6845/2021. The victim has still not been traced despite all the efforts by the police due to which the corpus could not be produced in the court. To trace the victim and to arrest the accused, it is deemed necessary to publicize the photo and other details of accused. The photograph and other details of the accused are enclosed with the letter. It is kindly requested to approve the request for publicizing the photograph and other details of accused throughout India (ISPW).
