In compliance of the Order dated: 08.12.2022 of Hon'ble Calcutta High Court in WPA no. 3998 of 2020, CBI has registered case no. RC0562023S0001 Dated: 23.01.2023 [U/s. 363/365 of IPC] by taking over the investigation of Kalyani PS (WB) case FIR no. 262.2017 dated: 19.07.2017. It was alleged in the FIR/complaint that on 16.07.2017 at about 06.00 pm, one Sri Santu Bhattacharjee (Aged - 16+ years) had left home at Shantinagar, Soguna, PO-Madanpur, PS-Kalyani, Distt-Nadia, WB for the Coaching Centre at Chatterjee Para, PO-Madanpur, PS-Chakdah, Distt-Nadia, WB and did not return thereafter.

During the investigation, CBI felt the need of a wide circulation of the details enclosed herewith amongst all SCRBS, PSs, all the different Govt & other offices, important places and establishments all over the States, Cities, UTs etc for information of all and a feed back of the same for trying chances of any information about the Boy.
